### 23. English for Academic Purposes

- 23.1 If you are studying the English for Academic Purposes course you must:
  - (a) maintain full-time enrolment in your English for Academic Purposes course (25 hours per week face to face teaching if you are studying Level 3 or Level 3 Extended, 20 hours per week face to face teaching if you are studying Level 4 or Level 4 Extended);
  - (b) achieve satisfactory progress throughout your English for Academic Purposes course; and
  - (c) maintain satisfactory attendance of at least 80% of scheduled class contact hours for your English for Academic Purposes course.
- 23.2 You acknowledge that, subject to clause 23.3, in the event that your attendance falls below 80% of scheduled class contact hours the University is obliged to notify the Department of Immigration and Border Protection that you have not achieved satisfactory attendance in your English for Academic Purposes course.
- 23.3 The University may, in its absolute discretion, decide not to notify the Department that you have not achieved satisfactory attendance of at least 80% of scheduled class contact hours if:
  - (a) your absence was due to compassionate and compelling circumstances (supported by appropriate documentary evidence, such as a medical certificate); and
  - (b) you are making satisfactory progress in your course; and
